

CMS Announces a New PQRS Web-Based Measures Search Tool

The Centers for Medicare and Medicaid Services (CMS) has announced the availability of a Physician Quality Reporting System (PQRS) web-based measure search tool.

How the Search Tool Can Help

The search tool can help Eligible Professionals (EPs) and PQRS group practices more easily identify claims and registry measures that may be applicable to them. This will enable them to find measures that meet satisfactory reporting requirements for the 2016 PQRS program year.

The tool allows users to search measure-related keywords. It also allows for the searching and filtering of measure-related information including:

- Measure Number
- Reporting Methods
- National Quality Strategy (NQS) Domain
- Cross-Cutting Measures
- Measure Steward

Users can click on a measure to view the individual claims and registry measure specifications available for 2016.

The Pennsylvania Medical Society (PAMED) encourages physicians and practices to utilize the search tool in helping them select their PQRS measures for 2016.

Proposed Solution to Surprise Billing Announced by PA Department of Insurance; Public Comments Sought

A proposed solution to the "surprise billing" problem was announced on Jan. 19, 2016, by the Pennsylvania Department of Insurance. This was in response to a hearing held Oct. 1, 2015, led by Pennsylvania Insurance Commissioner Teresa Miller, during which Brad Klein, MD, testified on behalf of the Pennsylvania Medical Society (PAMED). The Department is seeking feedback through a public comment period ending Feb. 29.

Surprise billing occurs when, for example, a patient goes to the hospital for surgery, and though the hospital and surgeon are in-network, unbeknownst to the patient, the radiologist, anesthesiologist, and/or other specialists are not. This can result in surprise medical bills to patients who weren't expecting them, and also can have negative effects on the physician-patient relationship.

PAMED is reviewing the Department's proposal and will be discussing with PAMED leadership.

Two-Midnight Rule Guidelines Revised – What You Need to Know

The Centers for Medicare and Medicaid Services (CMS) recently revised its guidelines on reviewing short-stay hospital claims for patient status for admissions on or after Jan. 1, 2016. "CMS announced that, despite the rule that says in order for a patient to be considered for inpatient status they have to be in the hospital for a period of time encompassing at least two midnights – that inpatient stays not meeting this requirement could still be considered for payment under Part A (inpatient dollars) on a case-by-case basis," said Mary Ellen Corum, director of practice support at the Pennsylvania Medical Society (PAMED).

Starting Oct. 1, 2015 Beneficiary and Family Centered Care Quality Improvement Organizations (BFCC-QIOs) began conducting initial patient status reviews of claims for inpatient admissions. Under the revised exceptions policy, which went into effect Jan. 1, 2016, for admissions not meeting the two midnight benchmark, CMS says that Part A payment may be appropriate on a case-by-case basis where the medical record supports the admitting physician's determination that the patient requires inpatient care, despite the lack of a two-midnight expectation.

CMS also said that BFCC-QIOs will consider complex medical factors such as history and comorbidities, the severity of signs and symptoms, current medical needs, and the risk of an adverse event to determine whether the medical record supports the need for inpatient hospital care.

It also said that recovery auditor patient status reviews will be conducted by recovery auditors for those hospitals that have consistently high denial rates based on the BFCC-QIO two-midnight short-stay review outcomes.
